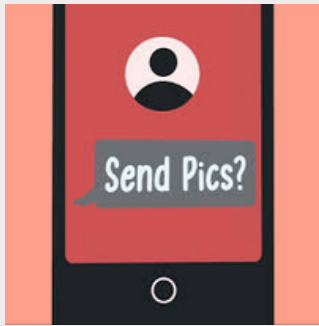

SEXTORTION PARENT PROGRAM

SEXTORTION IS A HOT TOPIC WE ARE HEARING ABOUT AMONG OUR PRINCIPAL GROUPS. WE ARE NOT IMMUNE TO THIS IN OUR COMMUNITY, AS THE MONMOUTH COUNTY PROSECUTOR'S OFFICE WILL SHARE WITH US. PLEASE JOIN US TONIGHT (4/16) AT 6:30 PM IN THE RUMSON MULTIPURPOSE ROOM, BEFORE THE GRADE 8 PARENT MEETING, TO LEARN MORE ABOUT THIS FRIGHTENING TREND. FOR THOSE OF YOU WHO HAVE NOT HEARD ABOUT SEXTORTION, AND WONDER IF THIS PROGRAM WILL BE HELPFUL, PLEASE REVIEW THIS EYE-OPENING INFORMATION.

SEXTORTION FACTS

- ✓93% OF THE VICTIMS ARE MALES.
- ✓1800% INCREASE IN NATIONAL CENTER FOR EXPLOITED AND MISSING CHILDREN (NCMEC) REPORTED CASES IN 2022 COMPARED TO 2021.
- ✓VICTIMS ARE MOST OFTEN AGES 15-17, WITH 60% OF THESE INTERACTIONS, STARTING AT AGE 13 (GROOMING).
- ✓51% OF VICTIMS WERE EXTORTED THROUGH INSTAGRAM.
- ✓31% OF VICTIMS THROUGH SNAPCHAT.
- ✓MORE THAN HALF OF THE VICTIMS RECEIVED THREATS BETWEEN 1 AND 9 TIMES A DAY.
- ✓IN NEARLY 33% OF THE CASES, OFFENDERS CARRIED OUT OR ATTEMPTED TO CARRY OUT THREATS AGAINST THEIR VICTIMS.

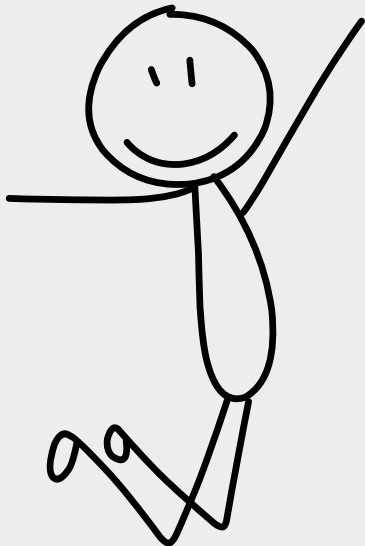
TAKE YOUR CHILD TO WORK DAY

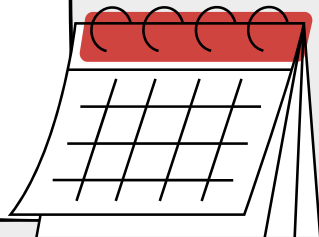
